- iv- The detailed instructions/FAQ's shall be made available on the official website of JK BOSE. Stakeholders in their own interest are advised to go through instructions/FAQ's before filling the Examination forms.
- v- The children with special needs (CWSN) candidates having a bench mark disability of Forty (40%) or more are exempted from paying examination/R.R renewal fee, however, they shall take a printout of the examination form submitted online and get it attested by the Head of the concerned academic institutions and submit the same in the concerned Sub/Branch office/s of JKBOSE along with the copy of Disability Certificate issued by the Competent Authority.
